# AIDS group treasurer quits, admits federal funds misuse

Prominent gay rights activist Bill Woods has resigned as treasurer of the Hawaii AIDS Task Group after admitting to board members he used \$2,050 in task group money to pay for improvements to his Honolulu home, Woods and a task group attorney said.

The task group directors have arranged for a full audit of the finances for the federally funded non-profit agency, which provides a discussion forum for public health workers and others working to fight AIDS and other sexually transmitted diseases.

The group also promotes research, study and programs related to AIDS.

Woods, who is editor and publisher of the monthly Gay Community News and executive director of the Gay and Lesbian Education and Advocacy Foundation, has long been an outspoken advocate on issues of concern to the gay community.

"It's been a very sad situation, and I've been deeply sorry about what has happened," Woods said in an interview after a board meeting Friday. He said he was sad "to have let them down in this way."

Woods said he is meeting with other groups he is associated with to explain the incident and ask if they want him to remain involved in their activities.

Woods was chairman of the Gay Pride Parade last year, and was a founder and executive director of the Gay Community Center. He is no longer connected with the center, however.

David Brustein, a volunteer attorney for the task group, said the board learned of the incident from Cheryl Embry, editor and publisher of Island Lifestyle Magazine.

Island Lifestyle is a monthly news magazine for the gay and lesbian community in Hawaii, and competes with Woods' publication, Embry said. She said a confidential source gave her copies of three checks Woods had written for the carpentry work.

Woods admitted to writing five checks on a task group account worth a total of more than \$2,000 for the home improvements, Brustein said.

Brustein said Woods also disclosed he had used \$2,200 in task group funds to buy a fax machine for the Gay and Lesbian Education and Advocacy Foundation (GLEA), which Woods runs.

On Dec. 20, Woods apologized to the board and agreed to resign, and also "agreed to help minimize the damage to the group and the community as much as possible," Brustein said.

He has since used GLEA funds to reimburse the board for the fax machine, and delivered a \$500 check to the board as his first restitution payment, Brustein said.

Woods said Brustein's account was "basically" correct. He said he was trying to help out a carpenter, whom Woods had known for a long time. Woods said he hired the carpenter as a favor when the

man was unemployed.

"It was not completely self-serving, although it was completely inappropriate," he said.

The task group has an annual budget of \$30,000 to \$40,000, most of which comes from federal funds, said board chairman Milton Diamond. The federal funding is administered by the state Health Department.

The Health Department plans to notify the state Attorney General's office, and it will be up to the attorney general to decide if any criminal action will be taken, Brustein said.

State Health Director John Lewin said he is waiting for a written report before taking any further action.

"We're happy that such a rapid response to the irregularities was effected by the AIDS task group," Lewin said.

The task group had all of the proper accounting and book-keeping safeguards in place for non-profit organizations, Brustein said.

Embry and some board members worried that there could be political fallout from the incident, particularly since Woods has been an outspoken advocate who appears frequently in media accounts.

But Diamond said he doubts the incident will do serious damage to the task group, which he said is a valuable organization.

The group brings together various agencies that work on the AIDS epidemic to exchange information, he said, adding: "Those that know we're doing a good job, they'll still know we're doing a good job."

"We know what we're doing is unique," he said. "The reason no other city has it is they fight with each other."
